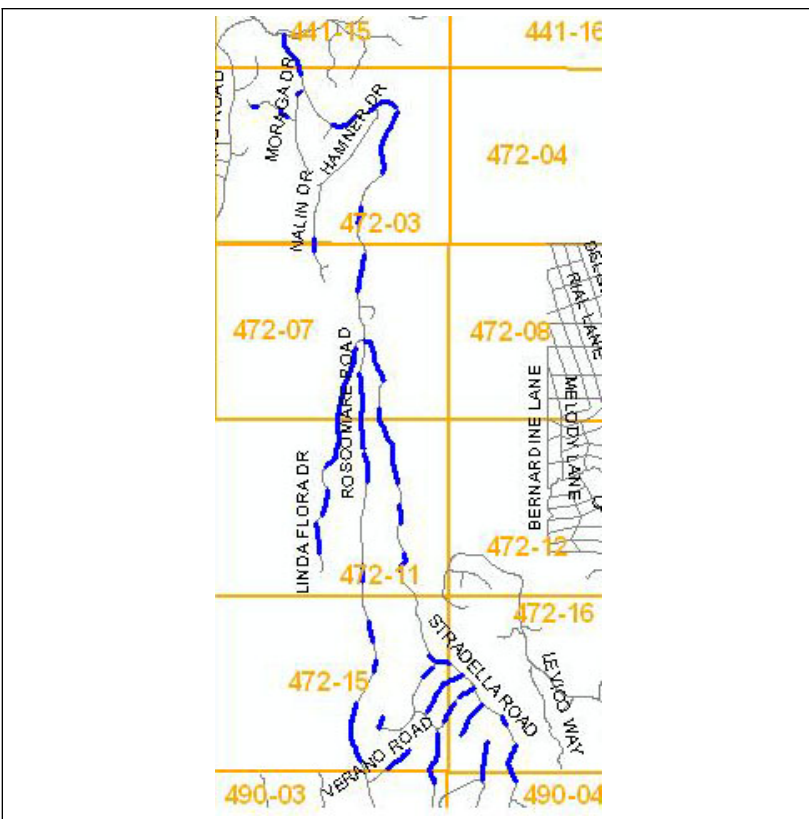

Construction	Based on Secondary Sewer Plan Report U18 produced by Bureau of Sanitation in January 2006, this project will remove and replace (R+R) or rehabilitate by lining approximately 3.77 miles of sewer pipes as part of the 60 Miles Sewer Rehabilitation and Replacement Program of the Settlement Agreement Program. The project is located in Bel Air - Beverly Crest in an area bounded by Mulholland Dr to the north, the Sepulveda Bl to the west, Beverly Glen Bl to the east and Sunset Bl to the south.
